Senator Schatz offered **SS** for **SR 436**:

SENATE SUBSTITUTE FOR SENATE RESOLUTION NO. 436

BE IT RESOLVED by the Senate of the One Hundred First General Assembly, Second Regular Session, that Senate Rule 84, be amended to read as follows:

“Rule 84. The previous question shall be in this form: “Shall the main question be now put?”. It shall only be admitted on written demand of [five] **ten** senators, and sustained by a vote of a majority of the senators elected, and in effect shall be put without debate, and bring the senate to direct vote upon a motion to commit, if such motion shall have been made; and if this motion does not prevail, then upon amendments, and then upon the main question. On demand for the previous question, a call of the senate shall be in order, but after a majority of the senators elected have sustained such a motion, no call shall be in order prior to the decision on the main question.”.

Senator Schatz moved that **SS** for **SR 436** be adopted.

Senator Onder offered **SA 1**:

SENATE AMENDMENT NO. 1

Amend Senate Substitute for Senate Resolution No. 436, Page 70, Line 6, by striking all of said line and inserting in lieu thereof the following: “be admitted on written demand of five, **and beginning January 1, 2100, ten**, senators, and”.

Senator Onder moved that the above amendment be adopted.

Senator Onder offered **SA 1** to **SA 1**:

SENATE AMENDMENT NO. 1 TO SENATE AMENDMENT NO. 1

Amend Senate Amendment No. 1 to Senate Substitute for Senate Resolution No. 436, Page 1, Line 4,

by striking “2100” and inserting in lieu thereof the following: “**2200**”.
