Legislative Successes



Senator Angela Walton Mosley joined Rep. Jay Mosley and the governor at the bill signing of SB 718 on June 16.

This session, I co-sponsored **Senate Bill 718**, which designates the third week of September as "Historically Black College and University Week" in Missouri. This legislation encourages residents across the state to organize and participate in events that celebrate HBCUs and recognize the impact of these incredible institutions in our state. This designation was also added to **House Bill 2627**, along with another provision I co-sponsored to establish the third full week in September as "Sickle Cell Awareness Week." September is the national Sickle Cell Awareness Month, and I am hopeful designating this week in our state will encourage Missourians to learn more about sickle cell disease and how we can best support those who are living with it. The governor signed SB 718 into law on June 16 and HB 2627 into law on July 1.

FY 2023 State Operating Budget

Covering House

\$4.1 Million

The Covering House provides recovery services for survivors of child sex trafficking. I had the opportunity to meet with Sherrita Allen, the organization's director, to discuss the future of the organization and how I can best help its mission. This funding included in the state budget is crucial for the Covering House to continue supporting survivors of child sex trafficking.

Jamestown Mall

\$6 Million

Lawmakers appropriated funds from the American Rescue Plan Act to demolish Jamestown Mall. It has been closed since 2014, and I am hopeful that space will be developed into a community area.

St. Louis Urban League

\$2.5 Million

The Urban League of Metropolitan St. Louis aims to empower African Americans and others in our community by securing economic self-reliance, social equality and civil rights. The Urban League's employment services provide resume writing, interviewing, job prospect and job placement classes to clients.

Save Our Sons \$1 Million

The Urban League also received funds for the Save Our Sons program which aims to help economically disadvantaged African American men living in the St. Louis region find jobs and have the opportunity to earn livable wages.

Other Budget Successes

- **Medicaid**: Fully funded Missouri's Medicaid program, including the constitutionally mandated expansion population, for the remainder of FY 2022, which ended June 30, and all of FY 2023, which began July 1.
- **Student Transportation**: Fully funded the state's share of public school districts' student transportation costs for the first time since 1991.
- Pay Raise for Teachers: Provided funding to ensure public school teachers are paid at least \$37,000 a year.

Another busy legislative session has come to a close. During the 2022 legislative session, I was able to pass several of my budget priorities, including important funding for the Covering House and the Urban League of Metropolitan St. Louis. The budget also fully funds Missouri's Medicaid program, including the constitutionally mandated expansion population, as well as the state's share of public school districts' student transportation costs. Additionally, public school teachers will receive a well-deserved starting pay of \$37,000 a year.

The governor signed into law legislation that included

provisions I co-sponsored to establish "Historically Black College and University Week" and "Sickle Cell Awareness Week" in September.
