AN ACT

To repeal section 70.631, RSMo, and to enact in lieu thereof one new section relating to the Missouri local government employees' retirement system.

Be it enacted by the General Assembly of the State of Missouri, as follows:

Section A. Section 70.631, RSMo, is repealed and one new section enacted in lieu thereof, to be known as section 70.631, to read as follows:

70.631. 1. Each political subdivision may, by 2 majority vote of its governing body, elect to cover 3 emergency telecommunicators, jailors, and emergency medical service personnel as public safety personnel members of the 4 5 system. The clerk or secretary of the political subdivision 6 shall certify an election concerning the coverage of 7 emergency telecommunicators, jailors, and emergency medical 8 service personnel as public safety personnel members of the 9 system to the board within ten days after such vote. The 10 date in which the political subdivision's election becomes effective shall be the first day of the calendar month 11 12 specified by such governing body, the first day of the calendar month next following receipt by the board of the 13 certification of the election, or the effective date of the 14 political subdivision's becoming an employer, whichever is 15 16 the latest date. Such election shall not be changed after 17 the effective date. If the election is made, the coverage provisions shall be applicable to all past and future 18

employment with the employer by present and future employees. If a political subdivision makes no election under this section, no emergency telecommunicator, jailor, or emergency medical service personnel of the political subdivision shall be considered public safety personnel for purposes determining a minimum service retirement age as defined in section 70.600.

2. If an employer elects to cover emergency
telecommunicators, jailors, and emergency medical service
personnel as public safety personnel members of the system,
the employer's contributions shall be correspondingly
changed effective the same date as the effective date of the
political subdivision's election.

32 3. The limitation on increases in an employer's
33 contributions provided by subsection 6 of section 70.730
34 shall not apply to any contribution increase resulting from
35 an employer making an election under the provisions of this
36 section.

[4. The provisions of this section shall only apply to 37 counties of the third classification and any county of the 38 first classification with more than seventy thousand but 39 fewer than eighty-three thousand inhabitants and with a city 40 of the fourth classification with more than thirteen 41 42 thousand five hundred but fewer than sixteen thousand inhabitants as the county seat, and any political 43 44 subdivisions located, in whole or in part, within such 45 counties.]
