AN ACT

To repeal section 558.047, RSMo, and to enact in lieu thereof one new section relating to sentence review for certain persons.

Be it enacted by the General Assembly of the State of Missouri, as follows:

- Section A. Section 558.047, RSMo, is repealed and one new
- 2 section enacted in lieu thereof, to be known as section 558.047,
- 3 to read as follows:
 - 558.047. 1. [(1)] Any person sentenced to a term of
- 2 imprisonment for life with or without eligibility for parole
- 3 [before August 28, 2016], a term of imprisonment amounting
- 4 to fifteen years or more, or multiple terms of imprisonment
- 5 that, taken together, amount to fifteen or more years who
- 6 was under eighteen years of age at the time of the
- 7 commission of the offense or offenses[,] may submit to the
- 8 parole board a petition for a review of his or her sentence,
- 9 regardless of whether the case is final for purposes of
- 10 appeal, after serving [twenty-five] fifteen years of
- 11 incarceration [on the sentence of life without parole] and
- 12 shall thereafter be eligible for reconsideration hearings
- 13 every three years until a presumptive release date has been
- 14 established by the parole board.
- 15 [(2) Any person found quilty of murder in the first
- degree who was sentenced on or after August 28, 2016, to a
- 17 term of life imprisonment with eligibility for parole or a
- 18 term of imprisonment of not less than thirty years and not

- 19 to exceed forty years, who was under eighteen years of age
- at the time of the commission of the offense or offenses may
- 21 submit to the parole board a petition for a review of his or
- 22 her sentence, regardless of whether the case is final for
- 23 purposes of appeal, after serving twenty-five years of
- incarceration, and a subsequent petition after serving
- 25 thirty-five years of incarceration.]
- 2. A copy of the petition shall be served on the
- 27 office of the prosecutor in the judicial circuit of original
- 28 jurisdiction. The petition shall include the person's
- 29 statement that he or she was under eighteen years of age at
- 30 the time of the offense, is eligible to petition under this
- 31 section, and requests that his or her sentence be reviewed.
- 32 3. If any of the information required in subsection 2
- 33 of this section is missing from the petition, or if proof of
- 34 service on the prosecuting or circuit attorney is not
- 35 provided, the parole board shall return the petition to the
- 36 person and advise him or her that the matter cannot be
- 37 considered without the missing information.
- 38 4. The parole board shall hold a hearing and determine
- 39 if the defendant shall be granted parole. At such a
- 40 hearing, the victim or victim's family members shall retain
- 41 their rights under section 595.209.
- 42 5. In a parole review hearing under this section, the
- 43 board shall consider, in addition to the factors listed in
- 44 section 565.033:
- 45 (1) Efforts made toward rehabilitation since the
- 46 offense or offenses occurred, including participation in
- 47 educational, vocational, or other programs during
- 48 incarceration, when available;
- 49 (2) The subsequent growth and increased maturity of
- 50 the person since the offense or offenses occurred;
