2023 Legislative Highlights

The goals I set when I began my second term as your state senator were to help senior citizens, reform dated criminal justice policies and secure needed funding for our community.

Unfortunately, the governor vetoed <u>Senate Bill 189</u>, which contained three of my priority proposals to simplify the process to expunge criminal records, compensate the wrongfully convicted and establish a statewide conviction review unit to investigate defendents' claims of innocence. I will file these important measures again in 2024.

I'm relieved the Senate blocked efforts to withhold vital funding from public libraries and agencies with diversity, equity and inclusion policies in place, raise the threshold to pass initiative petitions to 60% of votes cast and permit the state to reassume control of the St. Louis Metropolitan Police Department.

Some of the new laws that did emerge include extending <u>MO HealthNet</u> coverage to one year for postpartum women, <u>banning texting while driving</u> and reauthorizing tax credits for <u>motion picture production</u> and entertainment industry jobs.

Advocacy In Action

The word "advocate" has Latin roots that mean "add your voice to." Civic participation is a necessary part of the policymaking process and, in fact, the success of our democracy depends on it. I encourage you to get to know your local and state elected officials, offer to be their resource in your field of expertise and share your related personal stories. Tax Credits for Seniors

My highlight of the 2023 session was the governor signing **Senate Bill 190** into law. I was proud to co-sponsor this bipartisan legislation to provide needed financial relief to our seniors living on fixed incomes and struggling to keep up with rising real estate assessments.

This legislation is two-fold. One provision exempts all Social Security retirement benefits from state income tax, regardless of filing status or adjusted gross income. This law aligns Missouri with the other 40 states that do not tax Social Security income.

The other provision authorizes counties to grant a property tax credit to effectively freeze property assessment rates on senior citizens' primary residence. This tax credit and cap on assessment value increases will help retirees stay in their homes, which in turn will benefit entire communities.

Retirees work their entire lives to "earn their keep" in society and purchase property, so I'm glad this new law will enable them to keep their earnings and their homes!

Youth Advisory Board



This year's Youth Advisory Board tackled the issue of food insecurity in our community. Ably led by my former intern Colby Crowder, this dedicated group researched the root causes, toured area food production facilities and devised a gameplan to address this ongoing problem.

Investing in Our Community



Infrastructure, Workforce and Economic Development Initiatives



Born and raised in North County, my top priority is providing the resources needed to uplift our community, educate children and make our neighborhoods safe and prosperous. The state budget for Fiscal Year 2024 allocates \$2.25 billion in funding for vital St. Louis area projects and an additional \$430.1 million for capital improvements, maintenance and repairs.



\$15 million

The Advanced Manufacturing Innovation Center has been allotted funds to implement its strategic plan and establish an epicenter for research and development in St. Louis. This manufacturing facility will create jobs in the aerospace, agriculture and construction industries to spur economic growth and sustain long-term regional vitality.



\$5 million

The United Ways in Missouri will utilize this funding to leverage statewide partnerships, strengthen social safety nets and coordinate services. The enhanced programming will target social determinants of health through housing and utility assistance, help stabilize families and improve the trajectory of long-term outcomes for Missouri children.

Public Safety

\$10 million for the City of St. Louis Public Safety Access Point to consolidate emergency dispatch services and reduce response delays.

CORTEX MO

\$7 million for training and wraparound services to prepare unemployed individuals for jobs in cybersecurity and information technology.

Literacy

\$2.5 million to implement a statewide Literacy Reading Program and improve our students' below grade-level literacy rates.

Museums

\$2 million for the African American Museum and \$150,000 to the St. Louis Black Museum to preserve history and showcase achievements.

HOPE

\$250,000 in enhancements for Housing Options Provided for the Elderly to help older adults live with greater dignity and independence.

Fiscal Year 2024 Operating Budget

The Fiscal Year '24 operating budget totals **\$48.579** billion, the largest in state history. Flush with federal COVID-19 recovery funds, the budget allocates \$2.8 billion to widen Interstate 70 to six lanes, fully funds education and school transportation and expands mental health services. I am proud to serve on the Senate **Appropriations** Committee and of the spending plan we crafted.
