## AN ACT

To repeal section 210.516, RSMo, and to enact in lieu thereof one new section relating to the licensure of homes for children.

Be it enacted by the General Assembly of the State of Missouri, as follows:

	Section A. Section 210.516, RSMo, is repealed and one new
2	section enacted in lieu thereof, to be known as section 210.516,
3	to read as follows:
	210.516. [1.] It shall be unlawful for any person to
2	establish, maintain, or operate a foster home, residential
3	care facility, or child placing agency, or to advertise or
4	hold himself or herself out as being able to perform any of
5	the services as defined in sections 210.481 to 210.536,
6	without having in full force and effect a license issued by
7	the division; provided, however, that nothing in sections
8	210.481 to 210.536 shall apply to:
9	(1) Any [residential care facility operated by a
10	person in which the care provided is in conjunction with an
11	educational program for which a tuition is charged and
12	completion of the program results in meeting requirements
13	for a diploma recognized by the state department of
14	elementary and secondary education;
15	(2) Any camp, hospital, sanitarium, or home which is
16	conducted in good faith primarily to provide recreation,
17	medical treatment, or nursing or convalescent care for
18	children;

25 [(4)] (3) Any child placing agency operated by the 26 department of mental health or any foster home or residential care facility operated or licensed by the 27 28 department of mental health under sections 630.705 to 630.760 which provides care, treatment, and habilitation 29 exclusively to children who have a primary diagnosis of 30 mental disorder, mental illness, intellectual disability or 31 developmental disability, as defined in section 630.005; or 32

33 [(5) Any foster home arrangement established and 34 operated by any well-known religious order or church and any 35 residential care facility or child placement agency operated 36 by such organization; or

37 (6)] (4) Any institution or agency maintained or
38 operated by the state, city or county.

The division shall not require any foster home, 39 [2. residential care facility, or child placing agency which 40 believes itself exempt from licensure as provided in 41 42 subsection 1 of this section to submit any documentation in support of the claimed exemption; however said foster home, 43 44 residential care facility, or child placing agency is not precluded from furnishing such documentation if it chooses 45 to do so.] 46
