AN ACT

To repeal sections 300.295 and 304.035, RSMo, and to enact in lieu thereof two new sections relating to railroad crossings, with existing penalty provisions.

Be it enacted by the General Assembly of the State of Missouri, as follows:

Sections 300.295 and 304.035, RSMo, Section A. are 2 repealed and two new sections enacted in lieu thereof, to be known as sections 300.295 and 304.035, to read as follows: 3 300.295. Whenever any person driving a vehicle 1. 2 approaches a railroad grade crossing under any of the 3 circumstances stated in this section, the driver of such vehicle shall stop within fifty feet but not less than 4 fifteen feet from the nearest rail of such railroad, and 5 6 shall not proceed until he can do so safely. The foregoing 7 requirements shall apply when: 8 (1) A clearly visible electric or mechanical signal 9 device gives warning of the immediate approach of a railroad 10 train or any on-track equipment; (2) A crossing gate is lowered or when a human flagman 11 12 gives or continues to give a signal of the approach or passage of a railroad train or any on-track equipment; 13 An approaching railroad train or any on-track 14 (3)15 equipment is plainly visible and is in hazardous proximity 16 to such crossing. 17 2. No person shall drive any vehicle through, around or under any crossing gate or barrier at a railroad crossing 18

19 while such gate or barrier is closed or is being opened or 20 closed.

304.035. 1. When any person driving a vehicle approaches a railroad grade crossing, the driver of the vehicle shall operate the vehicle in a manner so he will be able to stop, and he shall stop the vehicle not less than fifteen feet and not more than fifty feet from the nearest rail of the railroad track and shall not proceed until he can safely do so if:

8 (1) A clearly visible electric or mechanical signal
9 device warns of the approach of a railroad train or any on10 track equipment; or

11 (2) A crossing gate is lowered or when a human flagman 12 gives or continues to give a signal or warning of the 13 approach or passage of a railroad train or any on-track 14 equipment; or

(3) An approaching railroad train or any on-track
equipment is visible and is in hazardous proximity to such
crossing; or

18 (4) Any other traffic sign, device or any other act,
19 rule, regulation or statute requires a vehicle to stop at a
20 railroad grade crossing.

2. No person shall drive any vehicle through, around
 or under any crossing gate or barrier at a railroad crossing
 when a train or any on-track equipment is approaching while
 such gate or barrier is closed or is being opened or closed.

3. No person shall drive a vehicle through a railroad
crossing when there is not sufficient space to drive
completely through the crossing.

28 4. No person shall drive a vehicle through a railroad29 crossing unless such vehicle has sufficient undercarriage

30 clearance necessary to prevent the undercarriage of the 31 vehicle from contacting the railroad crossing.

5. Every commercial motor vehicle as defined in 32 section 302.700 shall, upon approaching a railroad grade 33 crossing, be driven at a rate of speed which will permit 34 35 said commercial motor vehicle to be stopped before reaching the nearest rail of such crossing and shall not be driven 36 37 upon or over such crossing until due caution has been taken 38 to ascertain that the course is clear. This section does 39 not apply to vehicles which are required to stop at railroad crossings pursuant to section 304.030. 40

41 6. Any person violating the provisions of this section42 is guilty of a class C misdemeanor.
