Good afternoon, Senators, distinguished guests, and fellow Missourians.

Thank you. After a year as your President Pro Tem, I remain humbled and honored to serve in this role. This year has reminded me what is great about our state. It has also challenged us to make state government reflect the values of Missouri’s hardworking men and women.

So I ask this. Is Missouri state government meeting the challenges before us? Is it encouraging and supporting what makes us stronger and more prosperous? Or is it undermining our independence, our opportunities, our safety, and our future prosperity?

As I enter my last year in the Senate, I want to challenge all of state government to focus on basic priorities. We must be good stewards of the tax dollars hardworking families entrust to us. We must also create a business climate that provides family-supporting jobs and better opportunities for all Missourians.

Taxes, regulations, red tape, and bureaucracy do not make Missouri better. In every case, they take from Missouri families. They also take from Missouri small businesses and farms. Our job is to reduce their impact. We must make sure what we take is as limited as possible. We must also ensure it achieves important objectives and serves the common good of Missourians.

Missourians want results. They want better roads and better schools. They want more private homeownership. They want safe streets and neighborhoods. They want better jobs and stronger job skills. They want thriving communities. And they want less dependence on government at any level. These are the priorities Missourians expect the Missouri Senate to focus on. Our policies must reflect them. Our spending must align with them.

To support these goals, we must be persistent. We must closely examine the ideas we turn into laws. We must also scrutinize how we spend the budget we distribute. When we act on behalf of the people of this state, it should match their priorities.

The dollars we spend, the programs we run, and the policies we enact must improve the lives of Missouri families. We should also think about the next generation. For children born this year and beyond, what will they inherit? Will they inherit a state government that supports their health and safety? We must be there for them. Not to replace their parents. But as a community, we must build institutions that protect children from harm. We must help stabilize families and support them when needed. We must give children access to education and knowledge. We must also build critical thinking and practical skills so they can one day support themselves and their families.

I believe we can do better. I believe we can be a better resource and a better partner. Our goal should be greater opportunity for Missouri families and children than the generations before them. If we do that, we will help ensure Missouri is a great place to work, raise a family, and build a business.

We will do this together. And we will do it earnestly.

Missourians deserve tangible results. They deserve measurable outcomes. They also deserve transparency from state government.

State government has never taken more from its citizens. Over the last five years, Missouri's overall budget has grown by 40 percent. During that same time, wage growth has been modest, at about 3 to 4 percent per year. State spending increased at two to three times the rate of record-high inflation. That kind of government largess is unsustainable. It is also harmful.

So in this new year, let's focus on priorities. Let's support our families. Let's demand better results. And let's find solutions that move Missouri forward.

I refuse to measure the Missouri Senate by the number of bills we pass. I will measure it by the quality of what we pass. I will also measure it by the impact it has on the lives of our fellow citizens. I invite all of my colleagues from both sides of the aisle to participate in achieving these goals. Our state is better off when we consider all perspectives and work to find common ground.

All Missourians—young and old—need to know this. The Missouri Senate has not given up on the American dream. We have not given up on the Missouri dream. And our work this year will be focused on making a safer and more prosperous Missouri dream a reality.

## CONCURRENT RESOLUTIONS

Senator Trent offered the following Concurrent Resolution:

### SENATE CONCURRENT RESOLUTION NO. 11

Whereas, Article I, Section 1 of the Missouri Constitution recognizes that "All political power is vested in and derived from the people"; and

Whereas, the Tenth Amendment to the United States Constitution affirms that any powers not delegated to the federal government are reserved to the states or the people, reinforcing the principle of federalism; and

Whereas, the states have long served as laboratories of democracy, uniquely positioned to establish election laws and policies that reflect the needs and interests of their citizens; and

Whereas, a robust system of state-led election governance strengthens self-government, promotes accountability, and preserves the integrity of the electoral process by ensuring that the people of each state determine how best to protect their representation and participation in democratic processes; and

Whereas, the Framers of the United States Constitution recognized the role of the states in structuring election laws and mechanisms understanding that a one-size-fits-all federal approach is neither necessary nor desirable; and

Whereas, the people of Missouri and other states have a vested interest in ensuring that their electoral processes remain responsive to their needs and are free from disproportionate influence by foreign entities or individuals that may not reflect the priorities of the electorate; and

Whereas, the principle of self-governance requires that states retain the ability to establish laws governing the influence of money in elections, consistent with their unique circumstances and policy considerations; and

Whereas, the constitutional amendment process provides an avenue for reaffirming the role of the states in overseeing elections and ensuring that their authority in this realm is preserved:

Now, Therefore, Be It Resolved that the members of the Missouri Senate, One Hundred Third General Assembly, Second Regular Session, the House of Representatives concurring therein, urge the the Missouri Congressional delegation to uphold the principles of federalism and to be proponents of appropriate action, including, if necessary, a constitutional amendment that affirms the authority of states to govern their election processes and establishes the ability of the states to enact policies regarding campaign finance and election influence, in a manner consistent with established constitutional principles; and



Be It Further Resolved that the Secretary of the Senate be instructed to prepare a properly inscribed copy of this resolution to the members of the Missouri Congressional delegation.

Senator Moon offered the following Concurrent Resolution:

CONCURRENT RESOLUTION NO. 12

Whereas, American farmers and ranchers raise the best meat in the world; and

Whereas, Americans should have the right to knowingly buy made-in-America products; and

Whereas, American farmers, ranchers, workers, and consumers benefit from transparency on the origins of their food; and

Whereas, consumers have repeatedly and overwhelmingly expressed their support for country of origin labeling of food products in the United States; and

Whereas, in 2008, the United States Congress overwhelmingly passed mandatory country of origin labeling for muscle cuts and ground meat sold at retail, requiring meat produced from imported livestock or imported boxed meat to bear a different label from meat produced from United States born, raised, and slaughtered livestock; and

Whereas, trade groups and the organizations representing multinational meat packers worked predominantly with Canada, as well as Mexico, to bring a World Trade Organization case against the United States for the removal of the country of origin labeling requirements; and

Whereas, in 2015, the United States Congress repealed the country of origin labeling law for beef and pork, reducing the competitive advantage of products born, raised, and slaughtered in the United States; and

Whereas, the United States has the highest food safety standards in the world, while other countries place less emphasis on food safety; and

Whereas, foreign commodities like beef and pork are misleadingly labeled "Product of the USA" if they are processed or packed in the United States; and

Whereas, country of origin labeling gives producers and consumers the ability to distinguish true American products from foreign imported meat; and

Whereas, technological advancements make it possible to accurately and efficiently identify the origins of beef and pork without costly separation of imported and domestic commodities; and

Whereas, country of origin labeling is good for farmers, ranchers, workers, and meat packers because it allows them to identify their products as born, raised, and slaughtered in the United States; and

Whereas, the Missouri General Assembly supports American products, and consumers deserve the right to know the origins of their food:

Now Therefore Be It Resolved that the members of the Missouri Senate, One Hundred Third General Assembly, Second Regular Session, the House of Representatives concurring therein, hereby support the right of consumers to know the origins of their food, support the use of country of origin labels, and urge the United States Congress to reinstate mandatory country of origin labeling; and

Be It Further Resolved that the Secretary of the Senate be instructed to prepare properly inscribed copies of this resolution for each member of Missouri's Congressional delegation.

Whereas, Charlie Kirk authored multiple national best-selling books, that engage readers in critical conversations about civics, culture, and the future of the United States; and

Whereas, through Mr. Kirk's writing, public speaking, and media presence, Charlie Kirk reached millions of United States citizens, inspiring the next generation to become active participants in civic life; and

Whereas, Mr. Kirk's life's work has contributed to strengthening public discourse, defending constitutional principles, and fostering active citizenship; and

Whereas, Mr. Kirk's life work, especially his efforts to bring these American ideals to life on college campuses in the United States, cost him his life by means of an assassin's bullet on September 10, 2025:
