## **AN ACT**

To amend chapter 191, RSMo, by adding thereto one new section relating to disclosure to patients of certain physician benefits.

Be it enacted by the General Assembly of the State of Missouri, as follows:

Section A. Chapter 191, RSMo, is amended by adding thereto

- 2 one new section, to be known as section 191.885, to read as
- 3 follows:
  - 191.885. 1. As used in this section, the following
- 2 terms mean:
- 3 (1) "Drug or device company", a manufacturer,
- 4 developer, or distributor of pharmaceutical drugs or any
- 5 device used in the context of the physician's practice;
- 6 (2) "Open Payments database", the database created to
- 7 allow the public to search for data provided pursuant to 42
- 8 U.S.C. Section 1320a-7h and that is maintained by the
- 9 federal Centers for Medicare and Medicaid Services.
- 10 2. (1) A physician shall provide to each patient at
- 11 the patient's office visit a written and verbal notice of
- 12 the Open Payments database, as well as notice of any
- 13 benefits the physician has recorded in the database as
- 14 receiving relating to any pharmaceutical item, drug, or
- 15 vaccine that the physician is recommending, including any
- 16 benefits received from the manufacturer of such item, drug,
- 17 or vaccine.
- 18 (2) The written notice shall include a signature from
- 19 the patient or the patient's representative and the date of

the signature and shall include information on how to locate and access the Open Payments database.

- 22 (3) The physician shall include in the records for the 23 patient a record of the written notice required under this 24 section and shall give the patient or patient's 25 representative a copy of the signed and dated notice.
- 26 (1) A physician, or the physician's employer, 27 shall post in each location where the physician practices, 28 in an area that is likely to be seen by all persons who 29 enter the office, an Open Payments database notice, which 30 shall include, in easily readable font, an internet website 31 address for the Open Payments database and the following 32 statement: "For informational purposes only, a link to the 33 federal Centers for Medicare and Medicaid Services Open 34 Payments web page is provided here. The federal Physician 35 Payments Sunshine Act requires detailed information about 36 payment and other payments of value worth over ten dollars 37 (\$10) from manufacturers of drugs, medical devices, and biologics to physicians and teaching hospitals be made 38 39 available to the public.".
- 40 (2) Beginning January 1, 2027, if an internet website 41 is used for a physician's practice, the physician, or the 42 physician's employer, shall conspicuously post the Open 43 Payments database notice described in subdivision (1) of 44 this subsection on that website.
- 4. A physician who fails to comply with the provisions
  of this section shall be subject to discipline by the state
  board of registration for the healing arts.
- 5. The provisions of this section shall not apply to physicians while working in a hospital emergency department.
