ANACT

To repeal section 307.179, RSMo, and to enact in lieu thereof one new section relating to child passenger restraint systems, with penalty provisions.

Be it enacted by the General Assembly of the State of Missouri, as follows:

Section A. Section 307.179, RSMo, is repealed and one new

- 2 section enacted in lieu thereof, to be known as section 307.179,
- 3 to read as follows:
 - 307.179. 1. As used in this section, the following
- 2 terms shall mean:
- 3 (1) "Child booster seat", a seating system which meets
- 4 the Federal Motor Vehicle Safety Standards set forth in 49
- 5 C.F.R. 571.213, as amended, that is designed to elevate a
- 6 child to properly sit in a federally approved safety belt
- 7 system;
- 8 (2) "Child passenger restraint system", a seating
- 9 system which meets the Federal Motor Vehicle Safety
- 10 Standards set forth in 49 C.F.R. 571.213, as amended, and
- 11 which is either permanently affixed to a motor vehicle or is
- 12 affixed to such vehicle by a safety belt or a universal
- 13 attachment system;
- 14 (3) "Driver", a person who is in actual physical
- 15 control of a motor vehicle.
- 16 2. Every driver transporting a child under the age of
- 17 sixteen years shall be responsible, when transporting such

18 child in a motor vehicle operated by that driver on the 19 streets or highways of this state, for providing for the 20 protection of such child as follows:

- (1) Children shall be secured in a rear-facing child passenger restraint system until the child reaches two years of age, except that a child under two years of age may be secured in a forward-facing system when the child reaches the highest rear-facing weight or height allowed by the manufacturer of the particular car safety seat;
- (2) Children less than four years of age, regardless of weight, shall be secured in a child passenger restraint system appropriate for that child;
- [(2)] (3) Children weighing less than forty pounds, regardless of age, shall be secured in a child passenger restraint system appropriate for that child;
- [(3)] (4) Children at least four years of age but less than eight years of age[,]; who also weigh at least forty pounds but less than eighty pounds[,]; and who are also less than four feet, nine inches tall[,]; shall be secured in a child passenger restraint system or booster seat appropriate for that child;
 - [(4)] (5) Children at least eighty pounds [or children more than]; at least four feet, nine inches in height; or at least eight years of age shall be secured by a vehicle safety belt [or booster seat appropriate for that child] according to section 307.178; and
- 44 [(5)] (6) A child who otherwise would be required to
 45 be secured in a booster seat may be transported in the back
 46 seat of a motor vehicle while wearing only a lap belt if the
 47 back seat of the motor vehicle is not equipped with a
 48 combination lap and shoulder belt for booster seat

50 When transporting children in the immediate family 51 when there are more children than there are seating 52 positions in the enclosed area of a motor vehicle, the children who are not able to be restrained by a child safety 53 54 restraint device appropriate for the child shall sit in the 55 area behind the front seat of the motor vehicle unless the 56 motor vehicle is designed only for a front seat area. 57 driver transporting children referred to in this subsection 58 is not in violation of this section]. 59 This subsection shall only apply to the use of a child passenger restraint system or vehicle safety belt for 60 61 children less than sixteen years of age being transported in 62 a motor vehicle. 3. Any driver who violates [subdivision (1), (2), or 63 (3) of subsection 2 of 1 this section is quilty of an 64 infraction and, upon conviction, may be punished by a fine 65 of not more than fifty dollars and court costs. [Any driver 66 who violates subdivision (4) of subsection 2 of this section 67 68 shall be subject to the penalty in subsection 6 of section 69 307.178. If a driver receives a citation for violating 70 subdivision (1), (2), or (3) of subsection 2 of this 71 section, the charges shall be dismissed or withdrawn if the 72 driver prior to or at his or her hearing provides evidence 73 of acquisition of a child passenger restraint system or 74 child booster seat which is satisfactory to the court or the 75 party responsible for prosecuting the driver's citation.] 76 The provisions of this section shall not apply to any public carrier for hire. The provisions of this section 77 78 shall not apply to students four years of age or older who 79 are passengers on a school bus designed for carrying eleven 80 passengers or more and which is manufactured or equipped

pursuant to Missouri Minimum Standards for School Buses as school buses are defined in section 301.010.

5. The highways and transportation commission shall initiate and develop a program of public information to develop understanding of, and ensure compliance with, the provisions of this section.
