Senator Webber raised the following point of order, which was read:

POINT OF ORDER

Pursuant to Section 105.955 of the Missouri Revised Statutes, membership on the Missouri Ethics Commission is limited such that no more than one member may be appointed from any single United States congressional district.

The report before the body reflects four gubernatorial appointments that were made using the congressional district boundaries adopted in 2022. However, the Attorney General of Missouri has issued an opinion stating that the congressional district map adopted in 2025 is currently controlling for purposes of statutory compliance.

If the 2025 congressional district map is operative, then the appointments as reported would result in more than one commissioner being appointed from the same congressional district—specifically, two members from the First Congressional District and two members from the Fourth Congressional District. Such a result would be inconsistent with the statutory limitation set forth in Section 105.955.

Accordingly, if the Attorney General’s interpretation regarding the controlling congressional map is correct, the appointments as presented are not in conformity with statute and are therefore out of order. If, however, the 2022 congressional map remains controlling for these appointments, then the report would be in order.

I respectfully request a ruling from the chair on whether the report complies with Section 105.955, based on the applicable congressional district map.

The point of order was referred to the President Pro Tem.
