SCS for **SB 838**, entitled:

SENATE COMMITTEE SUBSTITUTE FOR SENATE BILL NO. 838

An Act to repeal sections 260.035, 393.1025, 393.1030, and 393.1050, RSMo, and to enact in lieu thereof four new sections relating to nuclear energy.

Was taken up.

Senator Cierpiot moved that **SCS** for **SB 838** be adopted.

Senator Cierpiot offered **SS** for **SCS** for **SB 838**, entitled:

SENATE SUBSTITUTE FOR SENATE COMMITTEE SUBSTITUTE FOR SENATE BILL NO. 838

An Act to repeal sections 260.035, 393.1025, and 393.1030, RSMo, and to enact in lieu thereof five new sections relating to the means of energy production.

Senator Cierpiot moved that **SS** for **SCS** for **SB 838** be adopted.

Senator McCreery offered SA 1:

SENATE AMENDMENT NO. 1

Amend Senate Substitute for Senate Committee Substitute for Senate Bill No. 838, Page 1, In the Title, Line 4, by striking “the means of energy production” and inserting in lieu thereof the following: “electric utilities”; and

Further amend said bill and page, section A, line 4, by inserting after all of said line the following:

“227.241. 1. For the purposes of this section, “electric transmissions facilities” shall include public utilities, investor owned utilities, utility cooperatives, municipal utilities, transmission only entities, and merchant transmission line developers.

2. For the purposes of this section, the term “highway” shall mean the public thoroughfare for vehicles, including public interstate highways, freeways, controlled access highways, and state and county highways.

3. Within highway rights-of-way, subject to reasonable engineering, safety, and access requirements, the commission and the department of transportation shall allow the installation, operation, and maintenance of electric transmission facilities, including high voltage and interstate transmission facilities.

4. The commission and the Missouri department of transportation shall develop uniform criteria for longitudinal and parallel colocation of transmission facilities within highway rights-of-way.

5. The duties of the commission and the department shall include:

(1) Providing reasonable timelines and procedure for review and approval of colocation requests;

(2) Ensuring the safety of the public and infrastructure;

(3) Avoiding duplication of corridors where colocation is feasible; and

(4) Imposing reasonable conditions for construction, right-of-way access, maintenance coordination, and restoration but shall not interfere with colocation.

6. The commission and department shall promulgate and enforce reasonable rules and regulations to implement the provisions of this section. Any rule or portion of a rule, as that term is defined in section 536.010, that is created under the authority delegated in this section shall become effective only if it complies with and is subject to all of the provisions of chapter 536 and, if applicable, section 536.028. This section and chapter 536 are nonseverable and if any of the powers vested with the general assembly pursuant to chapter 536 to review, to delay the effective date, or to disapprove and annul a rule are subsequently held unconstitutional, then the grant of rulemaking authority and any rule proposed or adopted after August 28, 2026, shall be invalid and void.”; and

Further amend the title and enacting clause accordingly.

Senator McCreery moved that the above amendment be adopted, which motion prevailed.

Amend Senate Substitute for Senate Committee Substitute for Senate Bill No. 838, Page 15, Section 393.1910, Line 24, by inserting after “4.” the following: **“The public service commission shall not increase the allowed return on equity for an electric utility solely because that utility is constructing a zero emission facility, as defined in subsection 1 of this section.**

“8. An electrical corporation, as defined in section 386.020, shall not demand any charge for service based on the costs of construction work in progress for any nuclear power generating facility.”

Further amend said bill, page 5, section 173.001, line 1, by inserting immediately after “173.001.” the following:

“1. The general assembly finds that all persons are equal before the law and are entitled to equal rights and opportunities under the law pursuant to article I, section 2 to the Constitution of Missouri and the Fourteenth Amendment to the Constitution of the United States. The general assembly condemns discrimination in all forms. Antisemitism is a form of discrimination. The purpose of this section and section 173.002 is to address discrimination, harassment, intimidation, and denial of equal access arising from antisemitism in educational institutions, consistent with the

constitutional rights of all persons.”; and further amend by renumbering the remaining subsections accordingly.

Senator Moon moved that the above amendment be adopted, which motion prevailed on a standing division vote.

Senator Trent moved that **SS** for **HB 2061**, as amended, be adopted which motion prevailed.
