DESCRIPTION

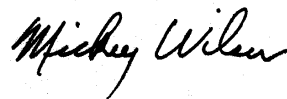
This act revises the maximum base compensation that can be offered to certain categories of Kansas City police personnel including the following:

1. Lieutenant colonels: from the current maximum of \$99,660 to the new maximum of \$106,764;
2. Majors: from the current \$85,848 to \$97,404; 3. Captains: from the current \$81,744 to \$88,860; 4. Sergeants: from the current \$66,972 to \$71,748; and 5. Detectives and Police Officers: from the current \$59,412 to \$63,648.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
