**FISCAL ANALYSIS**

**ASSUMPTION**

Officials from **Barry County, Lawrence County, McDonald County, Ozark County, Stone County,** and **Taney County** did not respond to our request for information on this proposal.

Officials from the **Office of the State Treasurer** and the **Office of the Secretary of State** assume this proposal would have no impact on their organizations.

Officials from the **Department of Public Safety, Division of Fire Safety,** assume this proposal would have no impact on their organization.

**Oversight** assumes this proposal would have no impact on the state, and would have no net impact on local government. Oversight assumes that fire and ambulance districts which receive property after the effective date of this proposal would have increased tax revenues and service responsibilities, and that districts which lose property after the effective date of this proposal would have decreased tax revenues and service responsibilities.
