### FISCAL ANALYSIS

#### **ASSUMPTION**

Officials with the **Department of Transportation**, **Department of Revenue**, **Missouri Highway Patrol** and **State Treasurer's Office** assume no fiscal impact to their agencies.

Officials with the **Department of Natural Resources** assume this proposal would allow a portion of the "Missouri Air Emission Reduction Fund" to fund programs that encourage alternative energy sources. This would take funds away from the Inspection and Maintenance program. The full extent of the impact from this proposal cannot be determined because the amount of the "portion" of funds to be used for alternative energy sources is not specified.

**Oversight** assumes that the cost of compliance with this proposal is unknown. Oversight assumes it is not possible to predict the programs that encourage alternative energy sources or the full extent of the impact on the funds to be used.
