FISCAL ANALYSIS

ASSUMPTION

Officials from the **Department of Health and Senior Services**, the **Department of Natural Resources**, the **City of Kansas City** and **Boone County** each assume the proposal would not fiscally impact their respective agencies.

In response to the previous version of this proposal, officials from **St. Louis County** stated this bill does not automatically specifically incur costs to the Department of Public Health (DPH). However, if the County chooses to add additional collection sites at DPH clinics or where the practitioners covered by this change are located, then some minor costs for the collection tools may need to be identified. Those costs are unknown at this time.

Oversight notes the provision of additional collection sites by the St. Louis County Department of Public Health is not mandated by the proposal. In addition, the County stated that the costs for collection tools should be minor. Therefore, Oversight assumes this proposal will have no significant fiscal impact on St. Louis County.

In response to the previous version of this proposal, officials from **Callaway County** assumed the proposal would not fiscally impact their agency.
