FISCAL ANALYSIS

ASSUMPTION

Officials from the **Missouri Senate (SEN)** assume the proposal as written would anticipate a negative fiscal impact to carry out the impeachment process. A special session would be called and the costs associated with a special session include: 2019 session per diem (\$119.20 per day) x 34 Senators, session staff (Sergeant-At Arms, Doorkeepers, Reverend, and support staff) at \$2,298.86 per day, and mileage (8,656 miles @ \$0.37 per mile) totaling \$3,202.72. Mileage is based on December 18 mileage with 31 Senators. Per diem is paid daily when in full-session only. Mileage figures are based on the payment of one (1) round-trip per week (statutory) and thus is the same for one (1) day or five (5) days if in the same legislative week without break. In summary, the first day of a special session would cost \$9,555 and each consecutive day would cost \$6,352.

Oversight notes that the Missouri Senate could potentially have a cost ranging from \$9,555-\$384,323 (\$9,555 + (\$6,352 x 59 days)) if a special session were called for the purpose of an impeachment. This range is based on the SEN estimate of \$9,555 the first day of a special session and \$6,352 per each day after and that special session cannot exceed 60 days.

Oversight notes that the costs associated with this proposal will only incur if there is an impeachment of the Governor and it occurs during a special session, therefore Oversight will reflect in the fiscal note a range of \$0 (no impeachment proceedings during a special session called therefore) or \$9,555 to \$384,323 depending upon the length of special session. Oversight will also reflect a potential savings from the special commission that would be established pursuant to Section 106.080 that would normally try the case under existing law.

In response to similar legislation SB 566 (4792-01) from 2018, officials from the **Missouri Lieutenant Governor** assume the proposal will have no fiscal impact on their organization.

Officials from the Office of State Courts Administrator, Office of the Governor, Missouri House of Representatives, and Attorney General's Office each assume the proposal will have no fiscal impact on their organization.

Oversight notes that the Office of State Courts Administrator, Office of the Governor, Missouri House of Representatives, and Attorney General's Office have stated the proposal would not have a direct fiscal impact on their organization. Oversight does not have any information to the contrary. Therefore, Oversight will reflect a zero impact on the fiscal note.

FISCAL DESCRIPTION

Currently, the impeachments of certain public officials are tried before the Missouri Supreme Court, except that the impeachment of a Governor or member of the Missouri Supreme Court is tried before a special commission. This act provides that all impeachments shall be tried by the Missouri Senate, except for the impeachment of a Governor, which shall be tried by the Chief Justice of the Missouri Supreme Court.

The provisions of this act are contingent upon the passage of a constitutional amendment that provides for the same changes to impeachment trials.
