FISCAL ANALYSIS

ASSUMPTION

Officials at **Boone County** assume an additional cost each year of \$1,100 from this proposal.

Officials at **St. Louis County** and the **Monroe County Assessor** each assume no fiscal impact to their respective entities from this proposal.

Oversight only reflects the responses that we have received from state agencies and political subdivisions; however, other counties were requested to respond to this proposed legislation but did not. For a general listing of political subdivisions included in our database, please refer to www.legislativeoversight.mo.gov.

Oversight notes this amendment allows counties to increase the reimbursement for members of planning and zoning commissions from \$25 per meeting to \$35 per meeting. Oversight notes this is at the discretion of the county commission. Oversight notes these planning and zoning commissions are authorized in section 64.800 in all counties except first class charter counties. Oversight notes that would leave 110 counties. Oversight assumes not all counties would have planning and zoning commissions and not all counties that have planning and zoning commissions would raise their reimbursement rate. Oversight will assume only first class counties will have planning and zoning commissions. Therefore, Oversight will range the impact from \$0 (county commissions do not increase the reimbursement rate) to \$11,760. This amount assumes 14 first class counties x an average of 7 members per commission x 12 meetings per year x \$10 increase.

Currently, members of county planning commissions may be reimbursed up to \$25 for the attendance at a meeting. This act increases the amount for attendance at a meeting to \$35.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
