FISCAL ANALYSIS

ASSUMPTION

Officials from the **Office of Administration (OA)** state that since it is not yet determined what terms the conveyance would be under or whether it will be conveyed we cannot assume what the impact would be. The fiscal impact as a result of this proposal is \$0 to either positive unknown or negative unknown, depending on the terms of the conveyance.

Oversight notes that the OA has stated the proposal could have a negative unknown impact or positive unknown impact, depending on the terms of the conveyance in this proposal. Oversight does not have any information to the contrary. Therefore, Oversight will reflect an Unknown to (Unknown) fiscal impact to the General Revenue Fund.

Officials from the **Office of the Governor** assume this section states that the Governor is authorized and empowered to sell, transfer, grant, convey, remise, release, and forever quitclaim all interest of the State of Missouri in certain property located in the city of Fulton, Callaway County, described in the bill.

There should be no added cost to the Governor's Office as a result of this measure.

Oversight notes that the above mentioned agency has stated the proposal would not have a direct fiscal impact on their organization. Oversight does not have any information to the contrary. Therefore, Oversight will reflect a zero impact on the fiscal note for the Office of the Governor.

Officials from the **Department of Natural Resources**, the **Department of Transportation** and the **Attorney General's Office** each assume the proposal will have no fiscal impact on their respective organizations.

Oversight notes that the above mentioned agencies have stated the proposal would not have a direct fiscal impact on their organization. Oversight does not have any information to the contrary. Therefore, Oversight will reflect a zero impact on the fiscal note for these agencies.

Officials from the City of Fulton and Callaway County did not respond to our request for fiscal impact.
