#### FISCAL ANALYSIS

#### **ASSUMPTION**

<u>Section 324.009 - Professional Licensing Reciprocity</u>

Officials from the **Department of Health and Senior Services (DHSS)** assume this proposed legislation revises the professional licensing reciprocity criteria necessary to qualify for a license in the state of Missouri, including nonresident military spouses. Applicants applying for licensure under the proposed legislation would fall under the same reciprocity process, fee, and review as current applicants. Changing regulations and applicant licensure reviews are within the normal ebb and flow for the Division of Regulation and Licensure, so minimal time and expense will be required to conduct the requirements of the proposed legislation.

The department anticipated being able to absorb these costs. However, until the FY21 budget is final, the department cannot identify specific funding sources.

**Oversight** does not have any information to the contrary. Therefore, Oversight will reflect a zero impact on the fiscal note for this agency.

Officials from the **Department of Commerce and Insurance**, the **Department of Natural Resources**, the **Department of Revenue**, the **Department of Agriculture** and the **Department of Transportation** each assume the proposal will have no fiscal impact on their respective organizations.

In response to the perfected version of this proposal, officials from the **Office of Administration** - **Administrative Hearing Commission** assumed the proposal would have no fiscal impact on their organization.

**Oversight** notes that the above mentioned agency has stated the proposal would not have a direct fiscal impact on their organization. Oversight does not have any information to the contrary. Therefore, Oversight will reflect a zero impact on the fiscal note.
