FISCAL ANALYSIS

ASSUMPTION

§188.035 - Born-Alive Abortion Survivors Protection Act

Officials from the **Office of Attorney General (AGO)** assume any additional litigation costs arising from this proposal can be absorbed with existing personnel and resources. However, the AGO may seek additional appropriations if there is a significant increase in litigation.

Oversight does not have any information to the contrary. Therefore, Oversight assumes the AGO will be able to perform any additional duties required by this proposal with current staff and resources and will reflect no fiscal impact to the AGO for fiscal note purposes.

Officials from the **Department of Corrections (DOC)** state although the bill repeals the potential to charge someone with murder in the second degree, which is a class A felony, DOC records do no allow for the identification of individuals whose convictions are based on actions outlined in the proposed legislation. Therefore, the DOC assumes no fiscal impact as a result of this proposal.

Oversight does not have any information to the contrary. Therefore, Oversight will reflect the no fiscal impact provided by DOC for fiscal note purposes.

Oversight notes the Department of Commerce and Insurance, the Department of Health and Senior Services, the Department of Public Safety, Missouri State Highway Patrol, the Department of Social Services, the Missouri Office of Prosecution Services, the Office of State Courts Administrator and the Office of State Public Defender have stated the proposal would not have a direct fiscal impact on their organizations. Oversight does not have any information to the contrary. Therefore, Oversight will reflect a zero impact in the fiscal note for these organizations.

Oversight only reflects the responses that we have received from state agencies and political subdivisions; however, local government-associated Hospitals were requested to respond to this proposed legislation but did not. A general listing of political subdivisions included in our database is available upon request.
