FISCAL ANALYSIS

ASSUMPTION

Officials from the **Department of Labor and Industrial Relations**, the **Department of Commerce and Insurance**, **Missouri Department of Conservation**, **Missouri Department of Transportation** each assume the proposal will have no fiscal impact on their respective organizations.

In response to the identical proposal, SB 693 (4056-01) 2021, officials from the **Office of Administration (OA)** assumed the proposal will have no fiscal impact on their organization.

Oversight notes each agency above stated the proposal would not have impact on their respective organizations. Oversight does not have any information to the contrary. Therefore, Oversight will reflect a zero impact on the fiscal note.

Officials from the **University of Central Missouri** notes they are unable to determine any fiscal impact at this time as UCM may not be required to comply under current designation as a state institution.

Oversight notes that University of Central Missouri is unable to determine fiscal impact arising from this proposal. Oversight assumes the University will be able to absorb any additional cost arising from this proposal within their existing budget. Therefore, Oversight will reflect zero impact on the fiscal note.

Officials from the **Missouri State University**, **Northwest Missouri State University**, **State Technical College of Missouri**, **University of Central Missouri**, and **Missouri University** each assume proposal would not have a direct fiscal impact on their respective organizations.

Officials from the **City of O'Fallon**, **City of Springfield**, **City of Kansas City**, **High Point R-III School**, and **Springfield R-XII School** each assume the proposal will have no fiscal impact on their respective organizations.

No direct fiscal impact to small businesses would be expected as a result of this proposal.


FISCAL DESCRIPTION
