FISCAL ANALYSIS

ASSUMPTION

Officials from the **Joint Committee on Public Employee Retirement (**JCPER) have reviewed this proposal. This proposal has no fiscal impact to the Joint Committee on Public Employee Retirement. The JCPER's review of this proposal indicates it will not affect retirement plan benefits as defined in Section 105.660(9).

Oversight notes this proposal allows the Board of the Firemen's Retirement Plan of St. Louis to act on behalf of all other city firefighter retirement plans in St. Louis City including the Firefighter's Retirement Plan of St. Louis. Oversight notes this proposal appears to be permissive and does not require the dissolution of other boards. Oversight assumes the dissolution of another board would require additional action at the local level; therefore, Oversight will not show a fiscal impact from this proposal.

Officials from the **City of St. Louis** assume this proposal (in combination with City Budget Bill 221) could reverse some of the cost savings achieved under the new retirement plan, the Firefighter's Retirement Plan of St. Louis.

Oversight notes the two firefighter retirement plans in effect in the City of St. Louis offer different retirement benefits for their members. Oversight assumes any decision by the Board to alter retirement benefits for the Firefighter's Retirement Plan of St. Louis would be an indirect impact.

Oversight did not receive a response from the Firemen's Retirement Plan of St. Louis or the Firefighter's Retirement Plan of St. Louis related to the fiscal impact of this proposal. Oversight has presented this fiscal note on the best current information available. Upon the receipt of additional responses, Oversight will review to determine if an updated fiscal note should be prepared and seek the necessary approval to publish a new fiscal note.
