## FISCAL ANALYSIS

## **ASSUMPTION**

Officials from the Missouri State Employees' Retirement System, University of Missouri, Missouri Local Government Employees' Retirement System, Public School Retirement System, Office of State Courts Administrator, Office of Administration - Administrative Hearing Commission, and Joint Committee on Public Employee Retirement assume the proposed legislation would not fiscally impact their organizations.

Officials from the **State Highway Employees' and Patrol Retirement System (HRS)** assume the proposed legislation does not change the requirement that the maximum division of a retirement benefit (in a divorce) will not exceed 50% of the annuity which is accrued during the marriage. The HRS officials assume the proposed legislation will have no fiscal impact on their retirement system.
