#### ASSUMPTION

OFFICIALS FROM THE DEPARTMENT OF REVENUE ASSUME:

THE SAFARI CLUB INTERNATIONAL HAS APPROXIMATELY 800 MEMBERS IN MISSOURI. IF IT IS ASSUMED THAT 5% OF THOSE ARE MEMBERS WILL APPLY FOR THIS SPECIALITY PLATE IT WOULD ONLY BE 40 APPLICATIONS. THIS WOULD HAVE A MINIMAL IMPACT ON THE DEPARTMENT OF REVENUE AND COULD BE IMPLEMENTED WITH EXISTING RESOURCES.

THE REVENUE GENERATED FROM THE ADDITIONAL \$15 FEE WOULD ALSO HAVE MINIMAL IMPACT BASED ON THE NUMBER OF Applications anticipated. If the number of applications increased, revenue would be affected accordingly.
