FISCAL ANALYSIS

ASSUMPTION

The **Joint Committee on Public Employee Retirement** indicates that this legislation does not represent a "substantial proposed change" in future plan benefits as defined in Section 105.660(5), and, as such, an actuarial cost statement is not required.

Officials with the **Kansas City Police Retirement System (KCPRS)** note that spouses of deceased retired members of the Police Retirement System of Kansas City or the Civilian Employees' Retirement System of the Police Department of Kansas City currently have the option to purchase health insurance at the same rate as all other retirement system members. Currently, spouses of deceased retired members can purchase a \$5,000 life insurance policy up to age 70 and a \$2,500 policy after age 70. However, KCPRS assumes the cost to allow for the purchase of the same amount of life insurance as that available to active members cannot be determined.

Officials with the **St. Louis Police Retirement System (STLPRS), Department of Insurance (INS)** assume the proposal presents no fiscal impact.

Officials with the **Department of Insurance (INS)**, **Missouri Consolidated Health Care Plan (HCP)** assume the proposal has no fiscal impact on their agency.
