Senate Bill 506: Improving Agriculture

We were able to make some much-needed improvements for Missouri's No. 1 industry this year.

Senate Bill 506 seeks to add captive deer to the definition of livestock, which would allow more venison to be processed and open a bigger meat market. It also would create the Missouri Dairy Revitalization Act of 2014, and lessen hauling restrictions and weight limits for farm vehicles. Senate Bill 506 would require the Missouri Department of Agriculture to promulgate the rule to make a label for E-15 on fuel pumps.

If the measure becomes law, it would take effect on Aug. 28, 2014.

Senate Bill 504: Increasing Transparency

I am pleased to say Senate Bill 504 now sits on the governor's desk.

Senate Bill 504 would require state agencies to make proposed rules available to the public by providing a Web page and a link to the Missouri Register, which would include all related material. Transparency is something I have been pushing for ever since I got to the Missouri General Assembly. We always hear cries for how difficult it is to follow government policies. I believe it is time to make sure everyone knows what these rules are, who they would affect and how much they may cost.

Senate Bill 745: Improving Conceal-Carry Laws

We learned a lot of lessons in 2013, after it was discovered that information connected to concealedcarry weapons (CCW) permits was going to the federal government. The Legislature acted quickly to ensure this never happens again. Senate Bill 745 includes provisions sheriffs need to carry out those changes.

Senate Bill 745 makes changes to a couple of different aspects of attaining your CCW permit. First, current law requires an applicant for a CCW permit to perform a physical demonstration of his or her ability to safely load a revolver and a semiautomatic pistol, a live firing exercise with both types of firearms, and a live firing test with both firearms. If this measure becomes law, the applicant only needs to demonstrate the ability to safely load, and only requires live firing from, either a revolver or a semiautomatic pistol.

If this common-sense measure becomes law, it would take effect on Aug. 28, 2014.

Senate Bill 668: Cutting Medical Costs

This year, I sponsored Senate Bill 663, a measure that requires health benefit plans to establish equal outof-pocket costs for covered oral and intravenously administered chemotherapy medications. I also supported House Bill 1327, which was a similar proposal. In the end, it was Senate Bill 668 that passed both chambers and was signed into law. In my opinion, this was one of the most important bills we passed this year.

This important legislation ensures access to effective life-saving treatments for cancer patients in Missouri. Working with the experts in the field, the legislation would bring insurance coverage parity to both forms of chemotherapy — intravenous (IV) and pill form simply requiring plans to cover oral chemotherapy products if traditional chemotherapies are already covered.

I am glad Senate Bill 668 made it across the finish line this year. The new law will officially take effect on Aug. 28, 2014.

- SB 504 Requires state agencies to post proposed rules, summaries, and fiscal notes on their websites (Passed)
- SB 506 Requires that all fees collected under the Missouri Livestock Marketing Law not yield revenues greater than the cost of administration (Passed)
- SB 561 Creates a permit for hobby manufacturers of fireworks
- SB 573 Authorizes Shelby and Monroe counties to collect a property tax to pay for road rock on county roads
- SB 745 Modifies the provisions regarding sheriffs and other law enforcement officers, weapons, and concealed-carry permits (Passed)
- SB 779 Allows Department of Corrections employees' overtime to accrue upon completion of time worked in excess of an employee's normal shift (Passed in House Bill 1090)
- SB 835 Requires county salary commissions to provide pay increases to sheriffs to be paid for from a fund in which certain fees received by the sheriff are deposited
- SB 850 Establishes a SNAP food stamps pilot project to encourage purchases of fresh food at farmers' markets (Added as an amendment to SB 727, which passed)
- SB 894 Modifies the interest rate applied to pre- and post-judgment money ordered in tort and nontort actions
- SB 902 Modifies the laws regarding certain private nuisance actions
- SJR 28 Creates the right to hunt, fish, and harvest wildlife
- SJR 29 Modifies the membership composition and terms of service of the commissioners on the Conservation Commission

Passed legislation awaits action from the governor.
